Machines over 95db will be black flagged immediately upon detection and disqualified from the event (no quietening or modifications once detected will be accepted as entry back in the event).

Subject to the Scrutineers approval of noise reduction measures the machine may be cleared to recommence racing.

A second infringement will result in immediate black flagging and exclusion from the meeting.

Unregistered vehicles not entered in competition may not be used at a permitted event unless authorised by the Clerk of Course and under official supervision.
